

ORDINANCE NO. 116 SUMMARY**

AN ORDINANCE OF THE BOARD OF DIRECTORS OF THE SAN SIMEON COMMUNITY SERVICES DISTRICT REPEALING ORDINANCE NO. 112 AND ADOPTING A NEW ORDINANCE NO. 116 MANDATING USE OF RECYCLED WATER STRICTLY FROM THE DISTRICT'S RECYCLED WATER FACILITIES

This Ordinance Summary is published in accordance with the provisions of Government Code Section 25124. On May 13, 2015, the San Simeon Community Services District ("District") voted to adopt Ordinance No. 116 repealing Ordinance No. 112 and adopting a new ordinance mandating use of recycled water strictly from the District's recycled water facilities. Ordinance No. 116 was approved unanimously by Directors Ralph McAdams, Alan Fields and Leroy Price with Directors Dan Williams and Ken Patel absent.

Specifically, Ordinance No. 116 requires all persons, customers and properties served by the District seeking recycled water or any non-potable water to only utilize the recycled water from the District's recycled water system. It also sets forth rules and regulations regarding the use of the recycled water, distribution priorities, and procedures for charging for the recycled water.

Ordinance No. 116 also provides notice and penalty provisions for violations of the Ordinance.
